II.1.4) Short description of the contract

The contracting authorities are partners in the HawkaMaa-EU Consortium implementing the project entitled “WASH assistance to support water governance and public water and wastewater services in Lebanon for host and refugee communities in Lebanon” funded by the European Union (EUTF/MADAD/2020/T04.272), within which they implement the Establishment-Led Service Improvement and Cost Recovery (ELSICR) Modality directly with all Water Establishments.

Within this framework, HawkaMaa-EU must procure equipment, supplies, and works on behalf of the Water Establishments supported by the project through various arrangements including, but not limited to, discrete supply and service contracts as well as long term framework contracts. The contracting authorities are therefore seeking through this joint procurement processes to select Providers (Contractors and Suppliers) for the implementation of the activities.

The current contract is for the Hydraulic supplies and Works, as described in the technical specifications of the tender dossier, distributed over four main lots. Each lot which will serve a separate WE and will be managed by one of the following project partners: WW-GVC, ACTED, Action Against Hunger and SI.

The Contracting Authority will award several framework agreements for each lot based on administrative and financial eligibility, as well as on technical compliance.

No financial offers are requested at this stage.

Subsequent to the initial framework agreements resulting from the current tender procedure which will lock in the technical requirements/specifications and offers for each item under the contracts, the Contracting Authority (CA) of each lot will launch separate Request for Quotations (RFQs) as the need arises. These RFQs will contain specific quantities for some or all of the items listed in the Contract BOIs, and to which suppliers awarded the FAs will respond to with financial offers. The lowest financial offer will result in the issuance of a Purchase Order (PO) for that RFQ, subject to conditions of contract of the respective FA.

The CAs do not guarantee that RFQs will be launched and/or awarded during the timeframes of the framework agreements, also, no minimum quantities of any of the items of the BOIs are foreseen to be purchased under these agreements.
