### Preamble

Representative Office “WE WORLD G.V.C. – Socially Oriented Non-Profit Organization” - intends to launch an International Tender procedure in the framework of the project entitled Rebuilding Childhoods: Integrated Support for Vulnerable Children in Kyiv funded by Taiwan. It's expected that the Taiwan will establish the final amount of the grant and will liquidate it to We World on completion of the operation on the basis of the expenses presented and declared eligible. No party other than We World shall derive any right from the grant or have any claim to its proceeds. Under no circumstances or for no reason whatsoever will the Donor entertain any request for indemnity or payment directly submitted by the humanitarian organisation's Vendors.

The procedures applied by We World in the present tender are inspired by the principles of:

- Transparency in the procurement procedures;
- Proportionality between the procedures followed for awarding contracts and the value of the contracts;
- Equal treatment and non-discrimination of potential Vendors and donors.

## A. CONTENT

### 1. Supply to be Delivered

The subject of the International Tender Procedure are 10 minivans.

The vehicles must comply with the technical specifications set out in Annex A1 and conform in all respects with description, measurements and other instructions.

### 3. Submission of the Bids

3.2. All Bids must be submitted in one original copy. The Bidders must sign and stamp all tender document pages including the required annexes. Failure to submit all required documentation may result in the exclusion from the procedure

- 3.4. All Bids submitted must comply with the requirements in the ITB and must comprise the following documentation duly signed and stamped:

## B. GENERAL CONDITIONS

4. Eligibility
- 4.1. Participation in tendering is open on equal terms to natural and legal persons with proven experience providing similar supplies
  - 4.2. The Contracting Authority will exclude from participation in the procurement procedure Bidders who are not in the position of signing Annex I, Annex II and Annex III of the present Tender.
  - 4.3. To be eligible for the participation in this International Tender Procedure, Bidders must be able to issue regular invoices and to declare that they comply with the General Conditions stated in this invitation to bid and annexes.
  - 4.4. The Bidder shall provide any detailed information requested by the Donor, the Contracting Authority, the Donor and by any other qualified outside body chosen by the Donor or by the Contracting Authority for the purposes of checking that the activities implemented in the context of the present contract are being properly carried out. The Bidder therefore allows the Contracting Authority, the European Anti-Fraud Office (OLAF), the Donors or third parties and the Court of Auditors to carry out the documentary and on-the-spot checks deemed necessary by the abovementioned authorities.
  - 4.5. Contracts shall not be awarded to Bidders who, during the procurement procedure:
    - (a) Are subject to a conflict of interest;

(b) Are guilty of misrepresentation in supplying the information required by the humanitarian organisation as a condition of participation in the contract procedure or fail to supply this information.

4.6. WW- shall exclude from participation in a procurement procedure Bidder falling into any of the following cases:

- They are bankrupt or being wound up, are having their affairs administered by the courts, have entered into an arrangement with creditors, have suspended business activities, are the subject of proceedings concerning those matters, or are in any analogous situation arising from a similar procedure provided for in national legislation or regulations;
- They have been convicted of an offence concerning their professional conduct by judgement that has the force of res judicata;
- They have been guilty of grave professional misconduct proven by any means that WW- can justify
- They have not fulfilled obligations relating to the payment of social security contributions or the payment of taxes in accordance with the legal provisions of the country in which they are established or those of the country of the contracting authority or those of the country where the contract is to be performed;
- They have been the subject of a judgement that has the force of res judicata for fraud, corruption, involvement in a criminal organisation or any other illegal activity detrimental to the Communities' financial interests;
- Following another procurement procedure or grant award procedure financed by the Community budget, they have been declared to be in serious breach of contract for failure to comply with their contractual conditions.

4.7. Bidders must certify by any relevant means that they are not in one of the situations listed above.

## 5. Language of offers

5.1 The language of the International Tender procedure is English

5.2 The bids all correspondence and documents related to the International Tender procedure exchanged by the bidder and the Contracting Authority may be written in local language; in this case, for the purpose of the International Tender Procedure their translation to English by the Contracting Authority will prevail.

## 6. Period of validity

6.1 Bidders shall be bound by their Bids for a period of 30 days from the deadline for the submission of Bids.

6.2 The successful Bidder will be bound by the bid for a further period of 60 days following receipt of the notification that the Bidder has been selected.

6.3 If the validity of the bidder is expired due to un-expected circumstances, WW- shall request from the Bidder (s) in writing to extend the validity of their bids without changing/modifying their prices. If the Bidder(s) request to change the offered prices, WW- reserves their right to cancel the Bidders offer

6.4 In exceptional circumstances, prior to the expiration of the bid validity period, WW may request Bidders in writing to extend the period of validity of their bids. A Bidder must confirm in writing his/her acceptance of the extension. In case of extension, modification of the bid is not permitted.

## 7. Currency and pricing

- 7.1 The offer prices shall be expressed in USD. For local vendors, in order to contracting, the offers will be recalculated in UAH based on the official exchange rate of the National Bank of Ukraine on the contract date for national vendors. Bidders are kindly requested to take this into account when preparing and submitting their offers
- 7.2 The prices will be Vat Included. The VAT should be indicated separately
- 7.3 The price should include of local taxes
- 7.4 The prices will be considered fixed and valid for the entire duration of the contract until the complete execution of the delivery. No additional charge of whatsoever nature and type will be accepted by the Contracting Authority.
- 7.5 The price shall include all the associated costs required to complete the supply (e.g. costs, duties, taxes, etc.)
- 7.6 The bidder shall bear all costs associated with the preparation and submission of his/her Bid, and WW shall not be responsible or liable for those costs, regardless of the conduct or outcome of the bidding process.
- 7.7 The prices submitted by any Bidder shall be checked for arithmetical errors and for what might be considered unreasonable rates during the evaluation. Where errors are identified one or more of the following steps may be taken:
  - a) If any rates are considered to be unrealistic or unreasonable they may be altered by mutual agreement, provided that no alteration shall be made in the amount of the Bid.
  - b) If any arithmetical errors are detected in an otherwise acceptable bid, and the Bidder, on being so notified, is prepared to confirm his bid and if the Bidder is subsequently awarded the contract, then the Bid shall be altered to reflect the difference.
  - c) The Bidder is reminded that it is entirely his responsibility to ensure the accuracy of his bid. No alteration will be made to the bid after its submission on the grounds of any arithmetical errors subsequently discovered except as provided above.

## 8. Ownership of Bidding Documentation

- 8.1 The Contracting Authority retains ownership of all bidding documentation received under this International Tender Procedure; consequently, Bidders have no right to have their bidding documents returned to them.

## 9. Subcontracting

## 10. ONE BID PER BIDDER PER CONTRACT

- 10.1 Each Bidder shall submit only one Bid per contract. A Bidder who submits or participates in more than one bid per contract will cause all the bids with the Bidder's participation to be rejected.

## 11. OBTAINING AND COMPLETING BIDDING DOCUMENTS

- 11.1 Bidders who did not obtain the Bidding Document directly from WW will be rejected during evaluation.

- 11.2 The Bidder is expected to examine all instructions, forms, terms, and specifications in the Bidding Document. Failure to furnish all information or documentation required by the Bidding Document may result in the rejection of the bid.

## 12. AMENDMENT OF BIDDING DOCUMENT

- 12.1 At any time prior to the deadline for submission of bids, WW may amend or cancel the Bidding Document by informing the bidders in writing.
- 12.2 To give prospective Bidders reasonable time in which to take an amendment or cancellation into account in preparing their bids, WW can, at his discretion, extend the deadline for the submission of bids.

## 13. Tender guarantee (Bid Security)

## 14. Performance guarantee OR Pre-Financing/Advance Payment Guarantee

- 14.1 Performance guarantee is not applicable

14.2 IN CASE OF Pre-Financing/Advance Payment. (2nd option of payment method, as per article 33.3): a pre-financing/advance payment guarantee is required:

The selected Bidder shall, together with the return of the countersigned Contract, furnish to the Contracting Authority with a guarantee for the full and proper execution of the contract. The amount of the guarantee shall be of 100% of advance payment. (30% of the total contract value).

The guarantee shall be held against payment to the Contracting Authority for any loss resulting from the Contractor's failure to perform its contractual obligations under the contract.

The guarantee shall be provided in the form of a bank guarantee.

The guarantee shall be denominated in the currency in which the contract is payable. No payments shall be made in favor of the Contractor prior to the provision of the guarantee. The guarantee shall continue to remain valid until the contract is fully and properly performed.

During the execution of the Contract, if the natural or legal person providing the guarantee is not able to abide by its commitments, the guarantee shall cease to be valid.

The Contracting Authority shall demand payment from the guarantee of all sums for which the guarantor is liable under the guarantee due to the Contractor's default under the Contract, in accordance with the terms of the guarantee and up to the value thereof. The guarantor shall, without delay, pay those sums upon demand from the Contracting Authority and may not raise any objection for any reason whatsoever. Prior to making any claim under the guarantee, the Contracting Authority shall notify the Contractor stating the nature of the default in respect of which the claim is to be made.

The guarantee shall be released within 45 days of the issuing of the signed final acceptance certificate for its total amount except for amounts which are the subject of amicable settlement, arbitration or litigation.

## 15. Insurance

- 15.1 N/A

**16. Guarantee Maintenance Service**

The vehicle warranty must be no less than 3 years or 100,000 kilometres of mileage.

The vehicle warranty stipulates that the seller is obliged to rectify all manufacturing defects arising during the warranty period. This includes the repair or replacement of parts that fail due to manufacturing faults, as well as the correction of defects in safety systems and mechanical components. All warranty obligations are carried out in accordance with applicable law and the manufacturer's or seller's regulation

**17. Delivery plan**

17.1 The eligible time limit for the delivery of all the items object of this contract shall be as per the following table:

Delivery shall be made to the supplier's location in Kyiv (DDP), where the vehicle must be stored for up to 14 calendar days, during which WeWorld is required to collect it.

Delivery time shall be as per offered delivery time stated in the offer.

## C. TENDER PROCESS

**18. Additional information before the deadline for submission of bids**

18.1 Prospective Bidders shall have - before the deadline for submission of bids - the chance to request additional information on the tasks to be executed under this contract. This request must be addressed in a written form within the deadline specify in the timetable (art. 2)

18.2 The Contracting Authority will provide written clarifications to all Bidders according to the deadline specify in the timetable (art. 2)

**19. Site Inspection**

1 WeWorld may request a meeting at the Contractor's office as well as at the location in Kyiv where the vehicles will be stored. The selection of the Contractor is made at WeWorld's discretion; however, if the inspection finds that the Contractor does not meet the required conditions, this may lead to disqualification.

**20. Deadline of Bid Submission:**

20.1 Bids must be received by WW at the address and no later than the date and time specified in the timetable (Art.2)

20.2 WW may, at its discretion, extend the deadline for the submission of bidders in writing.

20.3 Late Bids: WW- shall not consider and will reject any bid that arrives after the deadline for submission of the tender (or as extended by WW- to secure enough bids or any other reason based on sole decision of WW).

**21. Opening of Bids**

21.1 The Bids will be opened in public session by the committee appointed for the purpose. The committee will draw up minutes of the meeting, which will be available on request.

21.2 After the public opening of the bids, no information relating to the examination, clarification, evaluation and comparison of bids, or recommendations concerning the award of the contract can be disclosed.

## D. EVALUATION PROCESS

### 22. Confidentiality

- 22.1 No information will be given about the examination, evaluation and comparison of bids, or recommendations concerning the award of the contract
- 22.2 Any effort by any Bidder to influence WW- during evaluating of bids and on contract award decisions may result in the rejection of its Bid.

### 23. Clarifications during Evaluation Process

- 23.1 The Evaluation Committee may ask each Bidder individually for clarification of their bid, including breakdowns of prices. The request for clarification and the response must be in writing only, but no change in the price or substance of the bid may be sought, offered or permitted. Decisions to the effect that a bid is not technically compliant shall be duly justified in the evaluation minutes.
- 23.2 It is not allowed for the Bidder to change their offered prices EXCEPT to confirm the correction of arithmetical errors found by WW- in the evaluation of the bids.
- 23.3 In case of two bidders being scored the same in the evaluation, the one with the highest technical ranking will be awarded the contract
- 23.4 Anti-money laundering, anti-bribery, anti-corruption and anti-terrorism legislation applicable in some jurisdictions may require WW to verify the identity of the bidder prior to financial transactions. WW reserves the right to use online screening tools to check the bidder's record with regards to their possible involvement in illegal or unethical practices.
- 23.5 WW reserves the right to reject all bids, and re-launch the procedure if no satisfactory bids are submitted

### 24. Responsiveness of Bids

- 24.1 WW- will conduct a preliminary examination to the bids including the Administrative compliance, the Technical admissibility and financial evaluation of each Tender to confirm that all required documents and technical documentation requested have been provided, and to determine the completeness of each document submitted.
- 24.2 If any of the required documents – or any information are missed, the offer may be rejected based on WW- sole decision.

### 25. Evaluation Factors

- 25.1 All Bids will be evaluated in accordance of the evaluation factors described in the ITB and Evaluation Grid, WW- will evaluate firstly the administrative compliance review on Acceptable/Not Acceptable to determine if the Bids meet the mandatory requirements.
- 25.2 The criteria for selection, indicated in the Evaluation Grid will be based on the best value for money. Given that, WW is not bound to the lowest price or to any bid made as a result of this bid that is not technically responsive

The financial evaluation will be conducted as follows: the offer with the best price among all submitted proposals will receive 60 points, while all other offers will be scored according to the calculation formula

$$\text{Financial Score} = 100 \times \frac{\text{Lowest offer}}{\text{Bidder's Financial offer}}$$

The evaluation process will assess each vehicle individually, and total scores will be assigned per each vehicle (derived from technical and financial scores per vehicle). The winner for each vehicle will be determined based on the highest total score per vehicle, which includes both financial and technical scores per vehicle. Therefore, the contract may be split, awarded and performed by different contractors, with order of preference based on the rank of total score per vehicle

For example, if a supplier achieves the highest total score for 4 out of 10 vehicles, they will be considered the winner for those 4 vehicles. Winners for the remaining vehicles will be selected from other suppliers subsequent in highest total scores, using the same method, until all 10 vehicles have been assigned to a winner.

## 26. Correction of Errors

26.1 WW- shall correct arithmetical errors on the following basis:

- if there is a discrepancy between the unit price and the total price that is obtained by multiplying the unit price by the quantity, the unit price shall prevail and the line item total shall be corrected, unless in the opinion of “WW-” there is an obvious misplacement of the decimal point in the unit price or it is clearly and debatably non-logical, in which case the line item total as quoted shall govern and the unit price shall be corrected;
- if there is a discrepancy between words and figures, the amount in words shall prevail, unless the amount expressed in words is related to an arithmetic error, in which case the amount in figures shall prevail subject to (i) above.

26.2 The amount stated in the tender will be adjusted by the evaluation committee, in the event of arithmetical errors, and the Bidder that submitted the lowest evaluated bid should accept the correction of errors/the adjusted amount. If the Bidder does not accept the adjustment, its bid shall be rejected.

**27. Alteration or withdrawal of bids**

- 27.1 Bidders may alter or withdraw their Bids by written notification prior to the deadline for submission of Bids referred to in 04.05.2026 18:00. No tender may be altered after this deadline. Withdrawals must be unconditional and will end all participation in the International Tender Procedure.
- 27.2 Any such notification of alteration or withdrawal must be prepared and submitted in accordance with 04.05.2026 18:00. The outer envelope must be marked 'Alteration' or 'Withdrawal' as appropriate.
- 27.3 No Bid may be withdrawn in the interval between the deadline for submission of Bids referred to in 04.05.2026 18:00 and the expiry of the tender validity period.

**28. Cancellation of the International Tender Procedure**

- 28.1 WW reserves the right to reject/cancel any bid, or reject all bids at any time prior to contract award, without thereby incurring any liability to Bidders or any obligation to inform Bidders of the grounds for the WW decision/action
- 28.2 In the event of an International Tender Procedure 's cancellation, Bidders will be notified by the Contracting Authority. Cancellation may occur where:
- a. the International Tender Procedure has been unsuccessful, namely where no qualitatively or financially worthwhile bid has been received or there has been no response at all;
  - b. the economic or technical parameters of the project have been fundamentally altered;
  - c. exceptional circumstances or force majeure render normal performance of the project impossible;
  - d. all technically compliant Bids exceed the financial resources available;
  - e. There have been irregularities in the procedure, in particular where these have prevented fair competition.
  - f. The projects set to finance the operation has not been approved by the Donor.

In no circumstances will the Contracting Authority be liable for damages, whatever their nature (in particular damages for loss of profits) or relationship to the cancellation of a, even if the Contracting Authority has been advised of the possibility of damages. The publication of a procurement notice does not commit the Contracting Authority to implement the programme or project announced.

## **E. CONTRACT – GENERAL CLAUSES**

**29. Signature of the Contract**

- 29.1 The result of the International Tender Procedure will be communicated to all bidders in writing.
- 29.2 Within 5 working days of receipt of the contract already signed by the Contracting Authority, the selected bidder must sign and date the contract and return it to the Contracting Authority. Upon signing the contract, the successful bidder will become the Supplier and the contract will enter into force.

**30. Type of contract**

- 30.1 The contract that will be signed between the successful Bidder and the Contracting Authority will be a supply contract on WW template.

**31. Delivery Inspection and Acceptance of the Delivery**

- 31.1 The Contracting Authority will carry out one the inspection at the moment of delivery/preliminary inspection. The personnel carrying out the delivery inspection will also release delivery notes on the quality of the items.
- 31.2 The objective of the inspection of the supply is to assess the compliance with the terms of contract of:
- The quality of the items delivered
  - The quantity of items delivered

32. **Non conformity of delivery**

- 32.1 Quality, quantity and condition - Should the quality, quantity or the condition of the vehicles not satisfy the requirements of the contract at the moment of:
- a) PRELIMINARY inspection
  - b) DELIVERY inspection

They must be replaced by the selected supplier at his/her own expenses. The replacement must be executed as soon as possible, at the latest within 30 calendar days. The replaced cars are again subject to the rules laid down in the signed contract. In case the selected supplier will not be able to provide the requested quality of the vehicles, a payment deduction will be applied accordingly.

33. **Payment procedure**

- 33.1 All payments will be carried out in UAH for national vendors and in USD for international vendors via bank transfer to the Vendor 's bank account.
- 33.2 Payments will occur only after verification of the compliance of the supply with the technical specification attached as Annex B1 of this ITB and upon receipt of an original invoice issued by the selected vendor.
- 33.3 We World will pay the selected vendor through the following scheme:

1st option: 100% after the delivery of each of the items and submission of the original act of delivery.

2nd option: 30% advance payment based on an official bank guarantee and 70% after the delivery of each the items and submission of original act of delivery.

The payment is subject to the availability of funds. Should any delay occur, the Contracting Authority will inform the selected vendor in due time.

- Comply with all laws and regulations in effect in the country or countries of business;
- Respect human rights - Exploitation of child labor and all kind of sexual violence and sexual exploitation and abuse in the frame of the work or not (inside and outside the working hours and the working place) must be prohibited in accordance with We World PSEAH Policy
- Respect the basic social rights and working conditions
- Respect the environmental legislation
- Reject all the association of terrorism
- Not be involved in any activity linked to terrorism
- Avoid any relation with parties who support terrorism or who are linked to terrorist actions and funds

### 2) Fraud and corruption

The Contracting Authorities rejects any proposal put forward by tenderers or candidates, or, where applicable, terminate their contract, if it is determined that they have engaged in corrupt, fraudulent, collusive or coercive practices and they have involved in criminal organisations or any other illegal activity as specified in the We World (available at <https://www.weworld.it/scopri-weworld/conti-chiari-e-garanzie/>)

- Corrupt practice is defined as is the offering, giving, receiving or soliciting, directly or indirectly, of anything of value to introduce improperly the activities of the contracting Authority
- Fraudulent practice is any act of omission, including a misrepresentation, that knowingly or recklessly misleads, or attempts to mislead, the Contracting Authority to obtain a financial or other benefit or to avoid an obligation
- Collusive practice is an undisclosed arrangement between two or more tenderers or candidates designed to artificially alter the results of the tender procedure to obtain a financial or other benefit
- Coercive practice is impairing or harming, or threatening to impair or harm, directly or indirectly, any participant in the tender process to influence improperly its activities

The Contracting Authority strictly applies the transparency principle and rejects any conflict of interest. A conflict of interest exists where the impartial and objective exercise of the Contracting Authority is compromised for reasons involving family, emotional life, political or national affinity, economic interest or any other direct or indirect personal interest.

- This may also result from the involvement of technical assistance when the Contracting Authority uses a technical assistance contract to help drafting the tender specifications of a subsequent procurement procedure. In this case the Vendor can be rejected from the procedure when the Vendor, its staff or sub-contractors, such as expert(s), were involved in the preparation of procurement documents and this entails a distortion of competition that cannot be remedied otherwise.
- The Vendor has a professional conflicting interest that negatively affects its capacity to perform a contract. Such a situation arises where an operator could be awarded a contract to evaluate a project in which it has participated or to audit accounts that it has previously certified, and therefore is treated at the selection stage. If the operator is in such a situation, the corresponding tender is rejected.

For the duration of the contract the vendor and his staff declare to not be in any of the follow situation:
